Course Description

This course provides an introduction to Western art from the Renaissance to contemporary art of the 21st century. Major works in many media including painting, sculpture, installation art, and performance art will be covered. By the end of this course, students will have a visual vocabulary with which they can intelligently discuss and write about works of art. Regardless of whether the work is accessible and easy to admire or difficult and not readily understood, students will understand how to evaluate works of art not only for their beauty, but for other intrinsic values such as power of expression and boldness of communication.

Reading and Writing Assignments

Readings from the text will be assigned as homework followed by in-class lectures accompanied by image and/or video presentations with discussion on that material. A 7-10 page paper is due at the end of the semester, details to be provided (by discussion and a supplement to this syllabus) in class on September 14.

You are expected to be in class with a positive attitude. Participating in class discussions is to everyone's benefit. Those who participate often will receive a higher grade in this area. You should plan to spend a minimum of one hour in preparation for each class hour and to attend each class so that participation is maximized.

Course Requirements
