Prerequisite:

Successful completion of ACC* K115 with a "C" grade or better.

Course Description:

A study of the application of accounting principles and procedures to the cost control function of manufacturing business management. Emphasis is placed on managerial and analysis and control, job order costing, process cost, standard cost, and variance analysis. The course consists of four lecture hours.

Instructional Methodology:

This is an online class. There will be videos provided by the publisher, online homework, online exams, and conference calls.
