Course Description

The student will focus on holistic care of individuals and families across the lifespan with a variety of health care needs. The needs of clients experiencing endocrine, respiratory, gastrointestinal, cardiovascular conditions and selected mental health disorders are examined. Bioterrorism as a health care issue will be addressed. Clinical laboratory experience provides the student an opportunity to administer care to a diverse population of clients in a variety of acute care and community health care settings. The student will utilize critical thinking, caring, professionalism and communication skills in the care of the client. Emphasis is placed on provision of safe and competent care and development of the professional role as a member of a multidisciplinary health care team. Over the semester, the student is increasingly challenged in the clinical area with more complex client assignments.

Course Objectives

At the completion of this course, the student will be able to:

- 1. Implement principles of holistic care for individuals, families and groups from diverse cultures across the wellness-illness continuum.
- 2. Analyze multiple variables when implementing the nursing process in the care of individuals, families, and groups from diverse populations across the wellness-illness continuum.
- 3. Integrate evidence-based practice, quantitative reasoning and technology in providing competent care to individuals, families, and groups with intermediate health problems.
- 4. Utilize therapeutic communication techniques in providing care to individuals, families, and groups with intermediate health problems.
- 5. Implement a teaching plan for individuals, families, and groups with learning needs.
- 6. Integrate respect for human dignity through therapeutic relationships with individuals, families, and colleagues.
- 7. Function effectively as a member of the health care team.

- 8. Implement legal and ethical practice standards in providing care to individuals, families and groups with intermediate health problems in diverse health care settings.
- 9. Evaluate the professional nursing roles within the health care delivery system.

Nursing Program College Facilities

Facilities available to the students are: Faculty offices, the library, nursing classrooms, the nursing lab, the tutoring center, the writing center. These are located on campus. Computer labs are located within the nursing lab and throughout the E Wing.

Nursing 201 Clinical / Lab Experiences

Acute care clinical facilities include the following: WW Backus Hospital, Lawrence and Memorial Hospital, Windham hospital, Manchester Memorial Hospital and Day Kimball Hospital.

Orientation: All groups will attend orientation sessions for the med-surg experience. Times will be announced as per facility availability.

Clinical Observational Learning Activity: All students in good clinical standing will participate in observational activities with selected agencies. Dates of observation will be assigned as specified on your clinical rotation schedule.

Student nurse uniforms and college ID badges are required. Students must attend assigned observations as scheduled. Observational experiences are part of the required clinical hours and must be successfully completed to receive satisfactory passing clinical grade. Classroom labs with required validations will be presented as noted on course calendar. Uniforms and name tags are required for all on campus labs. Attendance is mandatory and counts as clinical time.

Clinical Equipment and Uniforms

Stethoscope, Watch with second hand, Bandage Scissors, Black pen, Notepaper, Assigned text, Uniform, ID Badge. Student nurse uniform per Student Nurse Handbook and identification, i.e. College name tag and/or hospital ID badge, are required for all clinical experiences.

Grading Policies

To pass Nursing 201 and progress in the nursing program, a student must do **ALL** of the following:

- Earn at least a 74 average in the theoretical portion of the course. Test items are drawn from ALL content of the course; theory, lab, clinical and math.
- Pass the clinical component of the course in a satisfactory manner.
- Pass Dosage Calculation Competency with 90% accuracy. See below testing policy.
- Pass required clinical skills validations. See policy below.
- Complete required standardized testing as scheduled for the course.

Evaluation Activities Reviewed: Examinations

There are five class examinations each worth 14% of the final grade spread out throughout the semester. See Quick view calendar. Each exam will be 50 minutes with 40-42 questions. There will be 10 pop quizzes scattered throughout which will count for a total of 5%. The additional 25% of the grade is based on the two hour final examination which is a cumulative exam containing between 80 and 85 questions. Bonus points may be added to the final exam based upon the students Proficiency Level achieved on the Custom Assessment of the standardized testing (ATI). Proficiency Level points will be determined by the CT-CCNP Committee prior to the final exam.

It is expected that all students will be present and punctual for exams. In the event that the student will be absent for personal illness, the student must notify the course leader prior to 8 a.m. on the morning of the exam. Failure to do so may result in a failing grade for that particular exam. Planned absences for vacations are **not** valid reasons for missing an exam. If warranted, **one** cumulative makeup exam will be offered at the end of the semester. Any student taking a make-up exam will have 15 points subtracted from the exam grade unless documentation of extenuating circumstances has been provided to and approved by the course leader.

Testing Procedures: Test answer bubble sheets will be distributed at 8:15 am, exams at 8:30 am. Students are required to complete the answer sheet as directed, which includes accurate Banner ID number. Students will have one hour to complete exams and 2 hours to complete the final exam. Students may not leave the exam room for any reason and return to the exam. All books, coats, backpacks, bags, etc. must be left in your car or placed in the front of the exam room. Eating and/or drinking are not permitted during exams. Students may not wear hats during exams. Calculators will be provided by the school. Wooden #2 lead pencils are to be used, no mechanical pencils. Anyone who looks at another student's exam or who is seen talking either to themselves or to someone else during the exam may receive an exam grade of 0. Exam scores will be posted on VISTA no later than 48 hours after the exam.

Students will be required to pass a dosage calculation exam with a grade of 90% or above. Calculators will be provided. The student will have three attempts to pass the exam. If unsuccessful, the student will need to go to the lab for remediation prior to rescheduling the next attempt with the course leader. The next exam must be scheduled at least one week from the most recent unsuccessful attempt. If the student is not successful on the third attempt, the student will be given the opportunity to withdraw. If the student chooses not to with draw, a failing grade will be given for the course. The student will be given the opportunity to apply for readmission.

Med calculation rounding rules:

- IV, IM and Infusion rates (any medication from a vial), should be rounded to the 10th (For example: 22.3, 27.6, 35.1)
- Infants: should be rounded to the 100th place
- Do not round UNTIL your final product/answer.

<u>Skills Validations:</u> Students in this semester will complete skills validations during lab #2. Students are strongly encouraged to practice the required skills in the lab prior to validation day. A student who is unsuccessful in validating must complete a lab referral remediating the skill with in one week, practice in the nursing lab, and then schedule an appointment with the lab to revalidate. If the student is unsuccessful a second time, the student must once again remediate the skill before making an appointment with the course leader to attempt a third time to validate. If the student is not successful a third time, the student will be given the opportunity to withdraw. If the

student chooses not to with draw, a failing grade will be given for the course. The student will be given the opportunity to apply for readmission.

Exam Review: Students may review concepts from the most recent exam with the lab staff. Any student receiving a 77.5 or less on an exam will be given a mandatory exam review with the lab staff.

Clinical Evaluation Activities:

Clinical performance is evaluated on the basis of how well the learner meets the objectives and achievements identified on the N2101 formative clinical evaluation form. Students must successfully meet the clinical objectives in order to pass the course. Clinical instructors will complete a weekly written formative evaluation of clinical performance, and will meet weekly with students to review student progress. A summative evaluation will be completed and reviewed at the end of the semester.

Clinical Absenteeism Policy:

The student who is absent for one clinical day will receive a CPIP. A second clinical absence will result in the student being placed on clinical warning. To be successful in the course, the student must earn removal from clinical warning status by having no further clinical absences the remainder of the semester.

If the student has more than 2 absences, the student will not be able to meet the clinical objectives resulting in a clinical failure, thereby, failing the course (please see the student nursing handbook).

Extenuating circumstances will be reviewed by the nursing faculty and the director of nursing. If there are greater than one absence in a specialty area, the student will be unable to meet the clinical and course objectives resulting in a clinical failure, thereby, failing the course. Extenuating circumstances will be reviewed by the nursing faculty and the director of nursing.

<u>Standardized Curricular Testing:</u> Standardized testing is required in order to pass this course. Please check the quick calendar for dates and times.

<u>Electronic portfolio-</u> All students are required to maintain an online learning portfolio in Digication that uses the college template. There will be one assignment during the course of the semester that will need to be uploaded into Digication. Completion of this assignment is a course requirement, and failure to complete it may result in an incomplete for the course. This assignment may be used by the general education assessment team on campus to measure college outcomes, and improve student experiences. There will be no identifying data on this assignment to link it to a particular student. However, you are encouraged to use this platform to reflect on, demonstrate, or showcase your growth throughout your time as a nursing student. Your portfolio will be private unless you choose to share it.

<u>Course Communication:</u> Communication in N201 is done exclusively through Blackboard learn messaging or using your SCHOOL email. It is important that you get in the habit of checking blackboard frequently, as you will be held responsible for communications sent to you.

Student Success in N201

Study Groups

Study groups are crucial to your N201 success. It is recommended that students participate in study groups. Study groups have been shown to promote student success.

When you decide to join a study group, pick a group that will give you the most benefit. Choose a group with students that are doing well and want to work hard. This may/may not be your immediate group of friends. For tips on making the most of study groups see the Blackboard posting on Tools for Success. The nursing lab has some space available to meet, as does the library. Staff within the nursing lab are available during posted hours to assist students with tutoring, skills, study/test taking skills, or other learning needs. Students are encouraged to be proactive in their learning and seek help independently. Learning resources can be found on the N201 Course Shell on Blackboard Learn, Text book Web Sites and CDs / DVDs, materials within the nursing laboratory and library, and the ATI website. Students are encouraged to utilize these independent opportunities frequently.

Methods of Instruction

Teaching modalities include lecture, power point, case studies, group activities, I-clickers, and simulation. Computerized programmed instruction and interactive learning tools may be used as well. Blackboard Learn and Digication are N201's learning management tools. Students are encouraged to participate in all activities offered to enhance the learning experience. Students are expected to participate in class discussions, class activities, roleplay, exam review and lab practice, and simulations. Participation enhances the learning experience and allows students and instructors the opportunity to learn from each other. Students are strongly encouraged to attend all classes. Tardiness, early departure, and absences have a direct impact on student learning.

Nursing Lab Resources

The Nursing lab is available for all students. The lab staff offer a wide variety of services to help students succeed. Students may be referred to the lab for tutoring, math skills, clinical skills, organization and time management, study strategies and test taking strategies. However, students do not need to be referred to get the benefit of all services the lab has to offer. Students who frequently use the lab find it to be a powerful tool for success.

<u>Professionalism:</u> The TRCC nursing handbook states "Professionalism is acquired through a complex process by which the nursing student internalizes values inherent to the practice of nursing. These values include integrity, legal-ethical standards, confidentiality, political awareness, and collegiality." Professionalism is more than clinical excellence. It is leadership. It is demonstrating nursing ethics and values in one's words, and in one's behaviors. Students will be held accountable to professional standards of behavior in the classroom, clinical, the nursing lab, and on social media.

Classroom and clinical demeanor is a vital part of professionalism. Students should behave respectfully at all times, recognizing each person's right to learn in an atmosphere conducive to the learning experience.

Do:

Be honest.

Have a positive attitude.

Be prompt, and be prepared.

Strive to be a positive, active member in class group work as well as in clinical as part of the health care team.

Avoid side bar conversations.

Listen when others are speaking.

Avoid negative body language such as eye rolling, loud sighs, smirking.

Keep cell phones turned off unless using them for class.

Speak respectfully to peers, instructors, patients, family, and health team members.

Refrain from gossip/complaining regarding peers, instructors, facilities, staff, and patients (HIPPA).

Refrain from social networking regarding peers, instructors, facilities, staff, and patients. (See social network policy)

Students who violate the guidelines of courtesy and/or professional demeanor will be asked to leave the setting, and will need to complete a performance improvement plan with remediation.

Nursing health and background check requirements: As per the Castlbranch ePortal (https://www.castlebranch.com), students who are non-compliant with health requirements, background checks, drug screening and CPR at any time, will be required to leave the program immediately. The student may request readmission if eligible in accordance with the CT-CCNP student readmission standards.
