**Report Presentation:** The report presentation will be three to five minutes long. A grading rubric will be provided to the students.

**Exams:** The midterm exam will be take-home essay.

**Research Report:** The student will select a terrorist organization and prepare a “briefing report”. The format will be provided in class.
