COURSE DESCRIPTION AND OBJECTIVES

This course provides an overview of U.S. law as it relates to business and commerce. Ethical implications will be discussed.

At the conclusion of this course the student is expected to:

- 1. have obtained a thorough understanding of the basic vocabulary of law;
- 2. have obtained a thorough knowledge of the history and principles governing business law in the United States; and,
- 3. be able to analyze unique facts and correctly apply governing principles using correct vocabulary.
