III. Course Description:

This course is designed to make the student aware of the fundamentals of the criminal investigation. The student will learn the correct procedures and conduct at the crime scene, how to preserve evidence, and the chain of custody. Emphasis is on the responsibility of the first responder. Additionally, students will review documentation, preparation, and testimony in court.

Chapter Questions: You are required to complete the chapter questions for ten of the 18 chapters. Five chapters are from prior to the midterm exam and five after the midterm exam.

Exams: Exams will be take home essay.

Research Paper: The paper will be on an approved topic of the student's choice. The topic must be related to this specific course and must be approved by the instructor by 10-04-2014. The paper will be at least eight, but no more than ten pages long. The paper must have at least five references; one reference must be from an academic journal the rest must be from academically acceptable sources.

The paper will be in APA style and will be written in Times New Roman 12 point type with standard margins. The paper will include a cover page that notes the title of the paper and all the relevant course and student information. Failure to use the APA format will result in a 25 percentage point reduction in the paper grade.

Late papers will be penalized 10 percentage points per week or part thereof.

Grades: All grades will be posted on Blackboard. The grades will be expressed in a point value. For example: an exam is worth 250 points, a grade of between 0

and 250 points will be recorded. The total amount of points earned during the semester will correspond to the grade scale listed below.
