Course Description: This course represents the Intermediate Algebra Instruction with embedded developmental support. The course cultivates understanding and different representations of functions. The course covers linear, quadratic, exponential, rational, and radical functions, equations and expressions and operations on them with emphasis on modeling and real world problems.

Prerequisite: MAT K09, MAT K095, or MAT K095I with a C- or higher; or appropriate placement through multiple measures assessment process.

Grading Policy: A student will receive one of the following grades: A, A-, B+, B, B-, C+, C, C-, D+, D, D-, F, W, P, or Audit. Your grade will be determined in the following manner:

- 1. Tests. There will be 5 tests given throughout the semester. The tests will be worth 40 percent of the final grade. There will be no make up test without a doctor's note. The lowest of the five scores will be dropped, if all five tests are taken.
- 2. Homework. Homework will be assigned at each class meeting throughout the semester and will be worth 15 percent of the final grade. All work must be shown. A list of answers is not acceptable. The homework should be kept in a notebook or an organized folder.

- 3. Final Exam. A comprehensive Final Exam will be given during the last class meeting. The exam will be worth 30 percent of the final grade.
- 4. Lab Participation. Students are required to use the ALEKS software for a minimum of three hours a week. A tutor and I will be available during the second class on Wednesday to assist. The on-line participation will be worth 15 percent of the final grade.
