Nursing 228 - Trends and Issues in Nursing, Spring 2006

COURSE DESCRIPTION:

Trends and Issues in Nursing utilizes a variety of e-learning activities to enable students to explore the history, trends, and current issues related to the role and function of the nurse. Contemporary history of nursing, nursing education, nursing practice, professional organizations, the health care system, and legal and ethical dimensions of the profession are emphasized. In addition students will prepare for entry into practice by preparing the professional resume and developing interview skills. This course must be taken in the final semester. Prerequisites: NURS 115, NURS 116, NURS 226. Corequisite: NURS 227.

COURSE REQUIREMENTS:

COURSE OVERVIEW:

Trends and Issues in Nursing, which is placed in the final semester, is designed to prepare the student for entrance into the social system of nursing as a profession.

The student is helped to sense his or her emerging place as an individual nurse within the employing agency, the health care system, the profession, and the nursing organizations.

Since stress is anticipated in the adaptive process ahead, the student is, to the extent possible alerted to the realities and how to deal with them through understanding the profession's history, the present bureaucratic structures in which nursing operates, the present issues facing nursing and the options for action open to its practitioners.

COURSE OBJECTIVES:**As a PROVIDER OF CARE:**

1. Explore issues related to nursing and/or the health care system and utilize the nursing process as the framework for approaching nursing issues.
2. Analyze stress-producing factors of the health care system that impact the client or nurse and develop coping strategies.

As a MANAGER OF CARE:

3. Utilize a variety of techniques to communicate views on nursing issues with individuals and groups, and bring about change in the system and the work setting.
4. Suggest techniques for communicating with fellow workers for improving client care.

As a **MEMBER WITHIN THE DISCIPLINE OF NURSING:**

5. Relate the activity of the nurse in the major professional organizations to the impact of organized nursing on nurses and the profession.
6. Apply knowledge of past major developments in nursing and society to the emerging trends and issues in the role and function of the nurse and nursing.
7. Select an appropriate place within the health care system in which to practice nursing.
8. Analyze factors impacting the health care system.
9. Analyze the nurse's legal, ethical, and professional role in assuring rights of clients and recipients of nursing care.
10. Suggest techniques for communicating with an employer to define the rights, responsibilities and expectations of the employer and employee.
11. Plan for future learning and professional development.
