## **Introduction to Human Services**

## **Course Description:**

This course is designed to familiarize the student with the current theory and knowledge related to human services> The course will include a survey of the helping professions including a history of social welfare and human service agencies. The course will include guest speakers and an opportunity to observe human service organizations. Students will be expected to complete ten (10) hours of volunteer service in the community.

**Course Assignments:** 

Assignment # 1:

Each student is to complete a ten (10) hour service-learning project at a social service agency in the community at large. A typed, 3-page report on the project is required.

Final position paper on the role of social welfare in a democracy such as ours. All papers must include a historical discussion that traces the roots of social welfare back to England, beginning at 1348. Select one theoretical perspective to explain your position on social welfare (liberal, conservative or radical). All assignments will be the result of each student's independent work. All papers must have a bibliography with at least 12 references. References are to be cited properly. Papers are to be no less than ten pages (10-12 pages are acceptable).
