<u>COURSE DESCRIPTION:</u> Students will learn about how countries conduct relations with each other and the varies theories about how they should interact. In addition, we will discuss where power comes from and ways to create a more peace peaceful and prosperous world.

ATTENDENCE: It is important that you attend class; you cannot learn if you're not there. Numerous absences will affect your grade. It is your responsibility to get all notes, materials, and assignments for any classes that you miss. Students MUST take the exam BY THE NEXT SCHEDULED CLASS TIME – NO EXCEPTIONS. Failure to follow this policy will result in either a grade of 0 on that test, a penalty of 10 to 20 points, and/or a make-up exam that is all essay. You will be allowed to take one make-up exam per class per semester.

Ten points per day will be deducted from any assignment that is late. In the real world, those who can't meet deadlines are fired.

<u>COUNTRY PROJECT</u>: Due: Monday, November 8. *PLEASE DO NOT EMAIL ME THE PROJECT*! This project will be 25-30 pages in length doublespaced. While that sounds like a lot, this project is very easy as it simply involves going to a website and looking up information and putting it in your words. I want you go to state.gov, (the Secretary of State's website, and click on "countries and regions" at the top. Once you do, you can access a list of all the countries. For each of the countries on your geography quiz, go to that countries page and look at the info.

- 1) Summarize (PUT IN YOUR OWN WORDS) the information under "people"
- 2) Summarize the info under "economy"
- 3) State the two events under "history" that you think influenced the country the most and help explain why it is the way it is. You can list more if you believe there are more than two such major events.
- 4) Briefly discuss the country's relationship with the US and other countries (available under the link to "background notes" and at the bottom of the background notes under "foreign relations"

In addition to the countries on your geography quiz, do this also for the West Bank by going to cia.gov and clicking the "world factbook" link on the left side. Once you click the world factbook link, go to "West Bank" where you will see major headings; click on the "+" in each heading to see the relevant information.

**RESEARCH PAPER**: Due Friday, December 3. Research a topic in International relations that interests you. Write a 5-6 page research paper on that topic, using at at least 8 sources, 4 of which may **NOT** be the internet. There are numerous suggested topics at cia.gov: you can go to "Policy issues," "economics and energy", "Arms control and security," and Democracy and global affairs," (links located at the top of the cia.gov home page) for a list of numerous topics that may interest you.
