### **Course Description**

This course involves comprehensive study of sources, distinctions and limitations relating to criminal law; the development of criminal law in the United States; the principles of criminal liability; the various crimes and their elements; and the criteria considered in determining capacity and defenses. Connecticut Penal Code is used to relate model Penal code and Common Law materials specifically to Connecticut. Case studies and briefs are used to emphasize the acts, the mental state and the attendant circumstances that are necessary ingredients in proving crime.

### **Course Objectives**

Upon completion of this course students should be able to:

Develop an understanding of the historical background of criminal law and the basic elements of common law crimes.

Assessment: written examination, class discussion

Articulate at the college level the importance of "elements" of the offense and the manner in which proof of these elements is established in court.

Assessment: Case Reports, chapter outline/ oral presentations

Identify and explain the common defenses available to those charged with crime.

Assessment: Case Reports, chapter outline, course discussion and oral presentations

To read case reports, interpret cases, write case reports in which information is identified, organized, synthesized and presented in appropriate format.
