#### **Prerequisite:**

Prerequisite: Placement score indicating placement in class greater than MAT\*K095 or successful completion of MAT\* K095 with a "C" grade or better <u>and</u> placement score indicating placement in ENG\* K101 or successful completion of ENG\* K096 with a "C" grade or better.

#### **Course Description:**

A study of basic accounting theory and practice as applied to the complete accounting cycle, including the use of current accounting systems and procedures and the preparation of financial statements.

#### **Instructional Methodology:**

This is an online class. There will be videos provided by the publisher, online homework and conference calls.

#### **Educational Objectives:**

To introduce you to the basic accounting principles and concepts, the accounting cycle, and financial statements.

The average of the assignments and discussion board postings will count as one semester exam. The homework assignments will not be accepted through email or if they are late.
