4. Identify issues, analyze, evaluate, and synthesis of variable and fixed costs.
5. Identify, formulate, analysis, and synthesis of Cost-volume-profit (CVP) analysis and relevant costs.
6. Identify, formulate, analysis, and synthesis of Contribution margin and break-even point.
7. Identify, formulate, analysis, and synthesis for margin of safety and sales target calculations.
8. Identify, formulate, analysis, and synthesis for variable and absorption costing
9. Identify, formulate, analysis, and synthesis of budgetary planning, control, and responsibility centers.
