Course Description:

A study of the application of accounting principles and procedures to the cost control function of manufacturing business management. Emphasis is placed on managerial and analysis and control, job order costing, process cost, standard cost, and variance analysis. The course consists of four lecture hours.

To provide the student with the analytical and quantitative skills necessary for making sound business decisions and to introduce students to the managerial applications of accounting information.

- 4. Identify issues, analyze, evaluate, and synthesis of variable and fixed costs.
- 5. Identify, formulate, analysis, and synthesis of Cost-volume-profit (CVP) analysis and relevant costs.
- 6. Identify, formulate, analysis, and synthesis of Contribution margin and break-even point.
- 7. Identify, formulate, analysis, and synthesis for margin of safety and sales target calculations.
- 8. Identify, formulate, analysis, and synthesis for variable and absorption costing
- 9. Identify, formulate, analysis, and synthesis of budgetary planning, control, and responsibility centers.
