# Course Description

In this class, students will get the opportunity to further their exploration of painting with acrylics through a variety of approaches including abstraction. Students will be encouraged to experiment with a variety of subject matter and themes as well as to develop their own individual styles. Studio: Meets 6 hours per week.

## Course Overview

Both representation and abstraction will be explored to create dynamic compositions. Students will be required to set their own goals for their paintings and to begin or continue to develop their own style of painting. Assignments will be worked on both in class and outside of class. Group critiques will be held on assignment due dates. On their due date, assignments should be complete at the beginning of class. Students should gain thoughtful methods of constructive criticism and be able to engage in an intelligent artistic dialogue. You should plan to spend a minimum of 3 hours per week on your work outside of class. Those that put forth effort in this class will inevitably show improvement in their work as the class progresses.

### Course Outcomes

Upon successful completion of Painting II students should:

Be able to depict volume and depth in their paintings through an understanding of the use of color.

Demonstrate an introductory understanding of abstraction and be able to create abstract compositions.

Be able to set their own goals for their paintings.

Begin to develop their own style of painting.

Be proficient in their ability to critique a work of art using an informed visual vocabulary and be able to engage in an artistic dialogue.

Complete an artist research paper, articulating the ethical dimensions surrounding the artist's works and identifying its historical, cultural, and aesthetic contexts.

### Writing Assignment

One 2-page research writing assignment will be required for this course. Students should use the library's research guides that are listed here: <a href="http://www.trcc.commnet.edu/library/Guides/artpage.htm">http://www.trcc.commnet.edu/library/Guides/artpage.htm</a> A group discussion will be held on the due date where each student will give the class a summary of his/her paper.

# **Digication**

You will be required to submit your writing assignment through the e-portfolio interface, Digication. All students who are enrolled in a degree program are required to maintain an online learning portfolio in Digication that uses the TRCC template. Through this electronic tool, students will have the opportunity to monitor their own growth in college-wide learning. The student will keep his/her learning portfolio and may continue to use the Digication account after graduation. A Three Rivers General Education Assessment Team will select and review random works to improve the college experience for all students. Work reviewed for assessment purposes will not include names and all student work will remain private and anonymous for college improvement purposes. Students will have the ability to integrate learning from the classroom, college, and life in general, which will provide additional learning opportunities. If desired, students will have the option to create multiple portfolios.

### Midterm Reviews

Each student will have an individual appointment with the instructor for the Midterm Review. At this meeting the student will receive their grade as is stands and will have a discussion regarding their performance and progress in class. Any other concerns the student or instructor has will be discussed.

# **Student Art Show**

There is a college-wide Student Art Show at the end of every academic year in May. All students who take an

art class are invited to submit one piece done in each class to this show. Pieces must be submitted through an instructor. Several cash prizes are awarded to students whose work is displayed in the Student Art Show by an outside juror.

#### Class Discussion

You are expected to be in class with a positive attitude. A positive and amicable environment is a good learning environment. Please keep your classroom conversations and language respectful of others and appropriate to the academic setting. Participating with energy and enthusiasm in class exercises, discussions and critiques is to everyone's benefit. Everyone should contribute frequently in each critique and discussion. Those who participate more will receive a higher grade in this area.

### Explanation of Criteria for Evaluation/Grade Weights

Projects- The average of all graded pieces comprises 50% of the final grade.

Class Participation (Includes participation in critiques and class discussions)- This comprises 20% of the final grade.

Studio Conduct (Includes how clean you leave the studio and your level of professional conduct in class)- This comprises 15% of the final grade.

Effort/Improvement (Includes how productive you are inside and outside of class and your improvement throughout the semester) - This comprises 15% of the final grade. Students who do additional work on their projects once they are graded, can hand the work in again at the end of the semester to earn extra points toward the Effort/Improvement portion of their grade.

## **Course Requirements**

Attendance- Please plan to attend all classes and to miss class only for extenuating circumstances. After 3 unexcused absences, each subsequent absence will result in a half-letter grade reduction to the final grade. Excused absences are only granted if legitimate written documentation is provided such as a doctor's note. An unexcused absence on a critique date will be recorded as two absences.

Tardiness/Leaving Early- Most class announcements are made either at the beginning or end of class. Students who arrive late to class or leave class early will not only miss hearing important information, but also are disruptive to the rest of the class, as the instructor may have to repeat information. Every four times a student leaves early or arrives late equals one absence.

Deadlines- Assignments not completed on time will be lowered one letter grade for each week they are late (an A becomes a B, a  $\sqrt{+}$  becomes a  $\sqrt{-}$ .)

Completion of all assignments and attendance at final critique- No student may receive a passing grade for this course without completing all assignments and must be present at the final critique to pass the course (unless a legitimate written excuse is provided.)

#### **Evaluation Procedures**

Projects will be collected for grading on their due dates. On their due dates, assignments should be complete at the beginning of class. Those that put forth effort in this class will inevitably show improvement in their work as the class progresses. All graded assignments may be resubmitted if you choose to rework them; you have two weeks from the date they were handed back to do so. Your grade will be adjusted accordingly.

## **Academic Dishonesty**

## **Electronic Devices**

Cell phones and other electronic devices must be turned off during class. Phones must not be answered in class. Text messaging or internet use is not permitted in class. Keeping the studio and your work area clean is part of your final grade. Please respect the studio and the other students who use it. You must clean up your work area at the end of class. Clean your easel ledge and throw away any trash. If you borrow any studio supplies, put them back. Studio art projects involving the use of any art materials other than pencils and pens must be worked on in designated art studios at the college only. Do not use art supplies such as paint, charcoal or glue in other areas of the college such as the cafeteria or student lounges as they may damage furniture and fixtures at the college.

### Hazardous Materials Statement

Acrylic paints are a hazardous material and must be handled with the proper care. There will be no eating while working with paints as this allows for possible ingestion of the paints. A 15-minute break will be taken during each class meeting. Any eating should take place then, outside of the classroom.

Although not as toxic as oil paints because they do not create fumes, the pigments used in acrylic paints are toxic. They should never be eaten or remain in contact with the skin for extended lengths of time. It is recommended that you wear rubber gloves when painting, but it is not required. If paint makes contact with your skin, wash the area as soon as possible so as to not allow the toxic chemicals to enter your body through the skin.

Liquid waste created in the painting process (your used water medium) may be poured down the drain, but solid waste materials such as excess unused paint, paper towels containing paint residue, or any other material containing paint residue should be placed in one of the red metal canisters under the sinks, not in the regular trash receptacle.
