#### **Prerequisite:**

Successful completion of ACC\* K115 with a "C" grade or better.

#### **Course Description:**

A study of the application of accounting principles and procedures to the cost control function of manufacturing business management. Emphasis is placed on managerial and analysis and control, job order costing, process cost, standard cost, and variance analysis.

#### **Instructional Methodology:**

This is an online class. There will be videos provided by the publisher, online homework, discussion posts, and conference calls.

#### **Educational Objectives:**

To provide the student with the analytical and quantitative skills necessary for making sound business decisions and to introduce students to the managerial applications of accounting information.

If a semester exam is missed, it is a zero. I will drop the lowest semester exam grade (Exam 1, 2, 3) or the homework average, <u>but I</u> will not drop the last exam grade.

I strongly urge you to do the homework exercises and watch the graded and/or informational videos on a weekly basis. You will have up to 3 submissions for each assignment. The homework assignments will not be accepted through email or if they are late.
