2.	President's Update	<ul> <li>President Jukoski provided a summary from a recent Regional Presidents Meeting.</li> <li>The current charge for all colleges is to protect our enrollment. Other matters discussed were:</li> <li>1. We need to ensure that faculty participate by Sept. 11<sup>th</sup> by taking class attendance so that a student can be contacted and supported if needed to remain in class.</li> <li>2. A virtual retreat regarding enrollment will be set up for all community college enrollment teams to plan for the spring semester.</li> <li>3. Flu shots should be coordinated on campus for all employees this fall.</li> <li>4. Students will have 45 days to make payments after the close of census before they are withdrawn.</li> </ul>

4.	Academic and Student Affairs Update	Kem Barfield shared that the program modality for on ground and on-line courses were reviewed as OAD is requesting this information from us.
